Q&A With the District

We encourage our customers to ask questions. If you have questions, please contact us. Here is a question that we received recently. It is a good question, and we thought we would share.

The Question:

A customer asked, "what is ok to put down in the garbage disposal?" The customer stated that 10 to 15 years ago they used to put all kinds of stuff down in the garbage disposal. Now, it seems you cannot put anything down in the garbage disposal.

The Answer:

As a wastewater utility, we are not a fan of garbage disposals. The garbage disposal creates significant issues for us as they give the perception that you can put anything down in them, which you cannot. You should not put anything down in the garbage disposal except water, soap, and ice. Over the past two decades, water conservation efforts such as low flow toilets, low flow shower heads, water efficient dishwashers, and cloth washers have resulted in less water in wastewater. This is great news as we are conserving water. However, we have seen a considerable reduction in wastewater flows. Unfortunately, there is less water in wastewater to move solid waste. The water in wastewater is the mode of transportation for solid waste such as poop. If there is less water to move solid waste, then it is more difficult to transport solid waste such as poop (or food that has gone through a garbage disposal, which we do not recommend putting in a garbage disposal). As an example, in the 1990s and 2000s you could purchase toilets that used 6 gallons of water per flush. Now, most new toilets only use 1.8 gallons per flush. As a result, the amount of water in wastewater has been reduced by almost 2/3 or 66%.

The short answer is garbage disposals are not trash cans, and we recommend only putting water, soap, and ice down in them. We also recommend using a drain strainer to catch any food or other debris from going down the drain.

DO NOT use toilets as trash cans. Items such as sanitary wipes, cotton swabs, diapers, cotton balls, floss, and kitty litter are common causes of sewer backups and should never be flushed.

For customers who have had their water service disconnected for non-pay, once payment has been received the District will only restore service from 8:00 am until 6:00 pm Monday through Friday and 8:00 am until 3:00 pm Saturday and Sunday. A \$50.00 After Hours Fee will apply for weekend restoration of service. If you want your water service restored during these times, please call 719-392-5534.
